On page 123, Section 7, During the Catastrophic Coverage Stage, the plan pays the full cost for your covered Part D drugs.	You enter the Catastrophic Coverage Stage when your out- of-pocket costs have reached the \$8,850 limit for the calendar year.	You enter the Catastrophic Coverage Stage when your out-of- pocket costs have reached the \$8,000 limit for the calendar year.	You must pay \$8,000 out- of-pocket for Part D drugs, then you will move to the next stage (the Catastrophic Coverage Stage) in 2024.
